## 4th Quarter 2026 Hires

Agents hired in the fourth quarter of 2026 will be measured as first-year hires, in their year of hire and in the entire calendar year of 2027. Fourth quarter hires will be measured under the Second calendar year requirement in their Second full year under contract (calendar year 2028).

## Club Credits

Club credits are sales credits from proprietary life & annuity sales. All business through ESI will be credited equally weighted at a 75% of GDC to comply with Regulation Best Interest requirements.
